# Eligibility for Registration

# **Chartered Architect**

Corporate Members of the Sri Lanka Institute of Architects are eligible to be registered under the category of Chartered Architects.

#### Architect

Non-corporate registered member of the institute or

Passed the Part II Examination of the Sri Lanka Institute of Architects, possesses required practical experience for the prescribed period and passed the Professional Practice examination conducted by the Council for the purposes of registration as an Architect

#### or

Obtained a Master of Science Degree in Architecture or equivalent as determined by the Board of Architectural Education of SLIA and possesses required practical experience and passed the professional practical examination conducted for the purposes of registration as an Architect;

### or

Obtained other educational or Professional qualifications in architecture, from an approved educational establishment or professional Institute, possesses required practical experience and passed the professional practice examination conducted for the purpose of registration as an Architect,

# **Architectural Licentiate**

(Non-corporate member of the Sri Lanka Institute of Architects)

Graduate member of the SLIA possessing required practical experience in an architectural capacity and passed the professional practice examination conducted for the purpose of registration as an Architectural Licentiate

Passed the Part 1 Examination of the Sri Lanka Institute of Architects and Possesses required practical experience in an architectural capacity experience and passed the professional practice examination conducted for the purpose of registration as an Architectural Licentiate.

Obtained the Bachelor of Science degree in Architecture with academic standards and training or equivalent as determined by the Board of Architectural Education of SLIA, possesses required practical experience and passed the professional practice examination conducted for the purposes of registration as an Architectural Licentiate

# or

Obtained other educational qualifications in Architecture from an approved educational or professional institution, possesses required practical experience in an

architectural capacity and passed the professional practice Examination conducted for the purposes of registration as an Architectural Licentiate;

#### or

Engaged in the practice of architecture in Sri Lanka or any other country for a period of not less than the required period and passed the professional practice examination conducted for the purpose of registration as an Architectural Licentiate.

Persons who wish to register in the ARB to practice the profession of Architecture in Sri Lanka shall comply with all other requirements specified in Sri Lanka Institute of Architects (Amendment) Act No. 14 of 1996.

# Apply for the first time

All persons to be registered as a chartered Architect, Architect or an Architectural Licentiate shall;

be over twenty one years of age; be a citizen of Sri Lanka; not adjudged by a competent court to be of unsound mind;

not have been adjudged an insolvent or bankrupt by a competent court or has not been granted by a competent court a certificate to the effect that his insolvency or bankruptcy has arisen wholly or partly from unavoidable losses or misfortune; or not have been convicted by a competent court, whether in Sri Lanka or elsewhere, of any offence involving moral turpitude and punishable with imprisonment or similar punishment and has not been granted a pardon.
